PUBLIC NOTICE
PROPOSAL TO AMEND RICHLAND TOWNSHIP'S
AGRICULTURAL SECURITY AREA

Richland Township of Bucks County, Pennsylvania has received a proposal to amend its agricultural security area by adding land to the already established agricultural security area, pursuant to the Agricultural Area Security Law, Act 43 of 1981. The proposal to add land to the existing agricultural security area is on file and available for public inspection at the Richland Township Municipal Building located at 1328 California Road, Quakertown, PA, Monday through Friday from 8:30a.m. to 5:00p.m.

Any affected Municipality or any landowners of property which is within, adjacent to, or near the area proposed to be included in the proposed agricultural security area may propose changes to the proposed agricultural security area. Any objections to the proposals or any proposed modifications to the proposal must be submitted to the Richland Township Assistant Township Manager at 1328 California Road, Suite A, Quakertown, PA 18951 by Friday, February 17, 2017.

Following Friday, February 17, 2017, which date is 15 days following the publications of this notice, the proposed additions to the Richland Township's agricultural security area and any proposed changes will be submitted to the Richland Township Planning Commission, the Bucks County Planning Commission and the Richland Township Agricultural Security Area Advisory Committee for review and recommendation.

Thereafter, a public hearing will be held by the Richland Township Board of Supervisors to consider the proposals, proposed modifications and recommendations of the planning commissions and the advisory committee.
