Fire Hydrant Flushing Notice **Richland Township Water Authority / Milford Township Water Authority**

Richland Township Water Authority and Milford Township Water Authority will be conducting their annual Fire Hydrant Flushing Program from April 17 through May 8, 2017. Flushing will be done Monday to Friday between the hours of 8:00 a.m. to 4:00 p.m. and in the following order:

- 4/27 Hunters Crossing, Goddard School, Trumbauersville Road, Mill Road
- 4/28 Milford Twp. & Trumbauersville Road, Tollgate Landing

PLEASE TAKE NOTE OF THE SIGNS THAT WILL BE POSTED ON THAT DAY TO INDICATE FLUSHING IN YOUR AREA.

As a customer, you may experience fluctuations in water pressure and/or discolored water during the time that flushing is near your area, as well as on your scheduled day. Normal service will be restored once flushing is completed.

We recommend that you turn off any filtering systems and bypass water softeners. Please refrain from washing clothes during flushing. If the discoloration of the water causes staining to any fixtures or laundry, please feel free to stop by our office to pick up a product that is designed to remove this staining.
