Andrea and John Clark – Richland Township

Mrs. Clark said she wrote letters to numerous members of the Township and also to Chief Ficco regarding a private firing range behind 210 Richlandtown Pike. She heard back from Mr. Staats, but hasn't heard anything from any member of the Township, and was wondering if there has been any discussion or is anything happening? She had pictures, documentation, and the ordinances that you already have.

Mr. Arnold said we had discussions about this in the Staff Meeting and Linc was looking into some ordinances.

Mrs. Clark said this all started in 2011. We moved into our house in 2008. The owner of 210 Richlandtown Pike bought his house in 2006. I was told by Mr. Brittingham and Mr. Treadwell they were given permission to fire guns in their backyard. I am not anti-gun, I own several. I support them and believe in the 2nd amendment.

Mr. Treadwell said when we were talking about the PA Game Code, it allows for people to shoot at targets in their back yard.

Mrs. Clark said it allows people to only shoot on Pennsylvania State Game lands. The PA Game Commission does not regulate target shooting in any residential area. She called the PA Game Commission and spoke in length with them. Title 34 of the PA Game Commission only applies to State Game lands.

Mr. Treadwell said if you look at our nuisance ordinance there is an exception for hunting. If you look at the definition of hunting in the State Game Code, it includes shooting at targets. When you look at our ordinance that says there is an exception for hunting, you then have to find the definition of hunting. The definition of hunting that is in the State Game Code includes shooting at replicas of animals. That is what Mr. Brittingham and I talked about years ago when this issue came up. He did not say the State Game Warden can regulate people shooting on their own property. What we pulled from the State Game Code was the definition of hunting. We never said they were given permission to shoot there. The question was is there something in one of our ordinances that prevents it? That is the question. If there is an exception under the nuisance ordinance and hunting includes shooting at targets, then based on the information we had, then is what we told you.

Mr. Clark said there are kids, teenagers that play in the woods, ride motorcycles, walk back there, in the wintertime they ride snowmobiles. Try living with 6 hours of constant gunfire. They do it Father's Day, Mother's Day, the day after Thanksgiving and Christmas. We have dates and times; 8:45 at night they are out there. The police told him "that's ridiculous, but our hands are tied because the Township allows it". One time we had a spent 45 round that ended up on the grill on our deck. We heard them shooting, we heard something hit the house.

Mr. Arnold said this is a very slippery slope, we have to be careful how we handle this, that we don't want to infringe upon somebody's amendment rights, however, we have to look at the well-being of the surrounding neighbors and children. Our job is now to find the balance. If we are looking, possibly looking into an ordinance that would be more specific to these situations. The zoning you live in is primarily SRL. You usually see that in residential developments. We definitely do not want anybody shooting there. We

now have to find a balance of what we are going to do and how we are going to handle this. I think we need to continue to look into and see what we can find. This is not going to be an immediate fix. If we adopt an ordinance it is going to take some time and advertising. I am going to have our staff continue to look into this and find out what we can do to best satisfy the needs, safety and well-being of people in the community.
